HORSE BOARDING CONTRACT

I hereby agree to board my horse by the name of _____

at **ROYALTON'S SUNRISE FARM**, So. Royalton, VT and to pay first month's board with this contract and monthly thereafter.

It is further agreed that:

1. Upon demand of ROYALTON'S SUNRISE FARM, INC., horse owner will submit a certificate executed by a certified veterinarian indicating that said horse shall be in good health, has a negative Coggins and is in good condition as of the time said horse shall be delivered for boarding, such certificate to be executed not more than thirty days prior to the date upon which said horse shall be delivered.
2. It is understood that ROYALTON'S SUNRISE FARM, INC. will not be responsible for accident, sickness or death to my horse, and that RSF will exercise it's judgement in caring for and supervising my horse.
3. It is also agreed that the owner or handler is responsible for any damages incurred by his horse to premises, other person's property etc.
4. In case of an emergency or for proper treatment and protection of said horse, ROYALTON'S SUNRISE FARM, INC. may call on the services of a veterinarian without first obtaining such consent of the horse owner and at the horse owner's cost and expense.

You care for the horse, furnish hay, feed, etc. Have use of indoor.

6. All boarding fees and other billed fees must be paid prior to the horse leaving the farm for any purpose.
7. Horse owner's account in arrears for 15 days will be charged interest fee; 60 days may result in the auction of the horse for payment.
8. This contract shall not be assigned or transferred by the horse owner.
9. This contract is not valid unless completed in full.
10. Children must be supervised at all times. **No pets allowed on premises.**
11. RSF will not be responsible for personal items including tack left on premises..
12. Thirty day notice is required by either party to terminate this contract.
13. Outside instructors not allowed by liability insurance unless certified and insurance rider provided.
